# **Principal's Report**

## **Student Success Planning**

- Three main areas for our student success plan literacy, math and student well-being.
- Of the three priorities, literacy and math are easy to discern where students are in their success, however well-being is a bit trickier to track. Overall when children's emotional, mental, and social well-being is prioritized, they are better equipped to engage and succeed at academic tasks.
- Well-being includes greeting students as they enter our building, building relationships with our students and recognizing various social and visual cues to determine how they are feeling.
- Additionally, giving students an opportunity to feel heard and valued in the school, including birthday announcements and specialized time that focuses on individual student needs
- For literacy and math, we continue to do guided groups to support short cycle planning to target students that need additional support. Phonic based programs such as UFLI are being used to help students develop their phonetic awareness.
- Each grade level was allocated \$1000 for school funds to make purchases to support the work of their SSP team. .

## Operational

- Victoria Green who was a long-term sub who went on maternity leave and was replaced by returning teacher, Payton DeWolfe.
- We held an SAC election with four candidates, Madhuruseka Aruchamy,
  Victoria Fernandez, Inbal Vichansky and Jennifer Wheadon. Jennifer Wheadon was the elected party to participate in our SAC as a co-chair.
- Fire marshall provided feedback regarding the 20% rule of combustible materials and unnecessary materials in classrooms that can affect our fire regulations.

## **Extra-Curriculars**

- Grade 3, 4, and 5 went to the Museum of Natural History.
- Grade 4's went to the Nutcracker at Alderney Landing.
- The primary Carleigh went apple picking.
- Grade 3,4 and 5's had egg farmers of Canada in to discuss how to prepare food.
